



Muddering Through

Jets, George Pierce, 10/13/11, 7:00pm

The weather for Monday, Tuesday and Wednesday had been nasty and when the **Jets** took the field on Thursday the trend continued. Rain had spit and sputtered all week, causing **The Cowboys** to get rained out Tuesday, but things were looking slightly better Thursday... until Thursday evening, anyway. It started raining at George Pierce a little before 6:00 and it rained for nearly half an hour. The already fairly saturated fields sported puddles at home plate and a few spots on the infields, but a little raking made the fields playable and the games were on. We had the 7:00 game and knew we'd be playing in slippery mud, but were glad we weren't playing at 8:00 or 9:00.

Our opponent was **The Firm**, the team who'd won the division, going 10-0, the previous season. We had gone toe-to-toe with **American Ale House**, who'd won the County tournament in the Spring season, and beaten the **Lookouts**, a hot team who used to be **Shake & Bake**, by run-rule, so we were ready to face anybody.

We were Visitors and got to bat first in the gooey mud and scored the first run of the ball game on a one-out double from **Tim** "ple of Doom" **McCoy**, but that's all we got in the first inning. **The Firm** scored five, three on a homer over the fence, and led 5-1 after one.

We came up with a run in the second, but so did **The Firm**, now 6-2 after two. We got rolling in the third inning, starting off with three singles for a run to close the gap to 6-3. Back-to-back fly-outs followed the RBI single, but a walk came next to keep us alive and load the bags. Another two-out walk from "Raggedy" **Andy Matz** pushed home a run, 6-4, then **Rob** "Martha" **Stewart** made it 6-5 with a single. **Mike** "Field of" **Reams** added a two-run single to put us up 7-5 then "Me from" **Adam Baker** doubled for a run to put us up 8-6, but an out at the plate, in treacherous running conditions, ended the inning. **The Firm** was good for a run in the bottom of the third, but we still led 8-7 after three.

We increased our lead to 11-7 in the top of the fourth inning when "Wild" **Bill Sarubbi** singled for a pair of two-out runs and "Eagle" **Rock McCoy** added a final run on a single. We were starting to get the hang of mud ball and were pulling away from **The Firm**, but they came out hitting in the bottom of the fourth and scored eight runs to retake the lead 15-11.

We answered **The Firm's** eight runs in the fourth, but we didn't answered as loudly as we'd hoped. We led off the fifth with three straight singles to load the bases. A fly-out made it 15-12, but a fly-out and line-out ended our budding rally. We hung a donut on **The Firm** in the fifth. In the sixth it was more of the same as we scored one more, this one on a two-out run on a single from "Dandy" **Andy Matz** to make it 15-13. With the clock dying before our eyes and under two minutes left, we set out to put **The Firm** down 1-2-3 so we could play a seventh inning and, surprisingly, our opponent obliged, whether on purpose or not. We'll never know why they were swinging at so many first pitches, but we didn't much care. We weren't looking a gift horse in the mouth.

We began the top of the final inning with a fly-out and a single. Another single gave us two down, but the salty **Jets** had no problem rallying with two down. We singled to put a second man on the bases then "Slim" **Tim McCoy** stroked a two-out single for a run, but a fielder's-choice ended the game and we lost 15-14.

The **Jets** play **Controlled Substances** next. This team is 1-7, having beaten only the **Scrubs**, hanging on 14-11.


Stay sharp, **Jets**, but let's have some fun. We should send these guys home in four innings, but let's have fun busting the ball doing it.

Attached is the first page of the ASA webpage concerning Illegal Softball bats. Make sure your bat has the proper stamp. If you're not sure, check the ASA website.

ASA Bat Testing & Certification Program

The official bat in ASA Championship Play must meet all of the requirements of Rule 3, Section 1 and:

1. must bear **either** the ASA approved 2000 certification mark **or the ASA 2004 certification mark** as shown below, and must not be listed on an ASA non approved list, **or**



2. must be included on a list of approved bat models published by the ASA National Office; or
3. must, in the sole opinion and discretion of the umpire, have been manufactured prior to 2000 and if tested, would comply with the ASA bat performance standards then in effect.

Beginning January 1, 2004, all bats in ASA Championship Play must pass the ASA 2004 bat standard. All bats having the 2004 certification mark will be allowed in ASA Championship Play. Bats that have the 2000 certification mark will not be allowed in ASA Championship Play unless they are listed on an approved bat list on the ASA website. For convenience, the ASA website has a listing of bats that do not pass the ASA 2004 bat standard.

2004 and Beyond Approved Bats (Updated: 12/5/2008)

For a list of bats that have been tested and found to comply with the ASA bat performance standards, and therefore are authorized to bear the **ASA 2004 certification mark** and/or are authorized for use in ASA Championship Play beginning January 1, 2004, please click on the manufacturer below.

Manufacturers continue to submit additional bat models for testing, and the ASA will update this list as test results become available.
